Family Science Association Business Meeting Re-Cap

The FSA meeting was held at the 2020 National Council on Family Relations Annual Conference held virtually on November 4th, 2020. Major items of discussion included confirmation that the FSA had received reimbursement for monies paid related to the cancelled 2020 conference. The 2021 conference co-Chairs announced that, after a survey of key stakeholders, the conference will be virtual in an effort to support the health and well-being of membership and in recognition of travel restrictions that many are experiencing this year. The website co-managers demonstrated the new website and described efforts to migrate past Family Science Reviewjournal issues to the new system. Payment of membership dues will be important in the months ahead to help finance the new website and membership portals that are under development. Copyediting services were renewed by the provider, and an increase in payment was approved. The Family Science Reviewediting team is working hard to process manuscripts after pandemic-related delays. 

MEMBER SPOTLIGHT: Robert E Keim, PhD, CFLE

Reflections by Deborah (Deb) Gentry, PhD, CFLE

Most Family Science Association (FSA) members referred to Robert E. Keim as "Bob," This last December, at age 91, he died of natural causes at his home in Clinton, TN. Though he contributed to FSA in many ways, his most vital role was as Editor of *Family Science Review* (FSR) from 1993-1996. One of his long-time colleagues remembers him as detail-oriented and methodical. He utilized those traits during his tenure as Editor, perhaps as a result of the accounting skills he honed early in his



professional life. His master's degree in divinity and ordained status later led him to serving several churches while living in California. Bob next earned a doctoral degree in Marriage and Family Living from Florida State University, which led to teaching positions there as well as at Colorado State University and Northern Illinois University (NUI). He retired from NIU in 1997 after 28 years there.

While at NIU, Bob was instrumental in developing and leading an academic program in Family Social Services. His attention to detail and thoroughness ensured the program was well-guided by various manuals, handbooks, and forms. He developed and taught two valued courses for the program: Group Process in Family Functioning, and Professional Practice in Family Social Services. Realizing his students had to rely on information about ethical dilemmas and behaviors originating from other fields, he joined Rebecca Adams, David Dollahite, and Kathleen Gilbert in developing and institutionalizing ethical principles and guidelines for family scientists. Ever since, students enrolled in and graduates of our academic programs are informed and abide by this ethical code of conduct as they carry out their studies and professional roles.

Bob was also a long-time, active member of the National Council on Family Relations (NCFR), achieving Legacy Circle status some time ago. He earned the Certified Family Life Educator (CFLE) credential and maintained it for over 30 years. For a number of years, he served as NCFR photographer during conference events. The proceeds of a book he co-authored with Arminta Jacobson, *Wisdom for Parents: Key Ideas from Parent Educators*, have been donated to the CFLE Scholarship Fund. For his dedication to furthering the success of the CFLE program, Bob was awarded the CFLE Special Recognition Award in 2011.

During much of his career, Bob was also busy raising four children as a single parent. I first met him when we served on the executive board of the Illinois Council on Family Relations. I became better acquainted with him during years we were active together in FSA and NCFR. He was a great mentor to his NIU, FSA, and NCFR colleagues. He provided me guidance and support during the brief time I served as FSA's journal editor. Bob recommended a NIU retreat center in Woodstock, IL, as the site for one of my favorite Teaching Family Science Conferences to have attended.

If you knew Robert E. Keim as a friend and fellow advocate for the well-being of families, you will no doubt miss him being among us, just as I will.

Additional priorities will be to explore processes that may allow an online first publication option, refining the review process through MStracker, as well as recruitment and expansion of our editorial team. Many journals have experienced a slower process of review as reviewers were experiencing a variety of impacts during the pandemic. We will be recruiting and expanding our team and focusing on both methodology and content expertise that can support us in processing submissions without adding too great of a workload on a smaller number of reviewers. I hope that everyone in the Family Science Association is safe and well and managing during this difficult time in our country.
